## DECREE:

**Article 1:** The authorization of Artisanal Miners Corporation binding the sales and purchase of precious metals and its concentrates.

**Article 2:** The various companies/corporations trading in precious metals and its concentrates from the various fields of Mining in Cameroon must purchase a **Obligatory Buyers Registration Permit**. This document would enable them to purchase precious metals from all MEMBER STATES.

**Article 3:** The various companies/corporations in sales of precious metals and its concentrates must be officially recognized by the Ministry of Industry, Mines and Technological Development.

**Article 4:** The exploited precious metals from the various Cameroonian fields of Mining by the recognized Corporations/Companies must be pre Assayed by a Governmental recognized research Centre. Dated copies of the test result sheet from the assayer must be shipped alongside the metal on International Basis.

**Article 5:** The various Corporation/Companies trading on Precious Metal and its concentrates must engage in:

- Keeping a record of the purchase and sales of Mineral Substances, signed and sealed by the Director of Industry.
- Operation of transactions only with precious metals and its concentrates.
- Delivering an activity report to the various assigned delegates of the department of mines with carbon copied to the Minister in charge of Mining every after 3 months.
- Informing the various assigned delegates of Mines to handle unforeseen circumstances such, accidents occurring during the course of Mining for the purpose of commercializing Mineral Substances.



**Article 6:** The signed and sealed contracts from the various parties involved in the sales and purchased of precious metals must be deposited alongside the goods to be shipped to the property storage Bureau at the consideration during this process.

-The various parties concerned for any transaction- shall undergo a verification process, different verification tools would be use. The various findings during this process would determine the eligibly of the transaction.

-Upon a position test result from the Findings, the Buyers and would purchase a Obligatory Buyers Registration Permit. Further instructions as to the purchased of this document would be provided the designated party concerned at the Department of Mines and Geology.

-In situations whereby the purchaser for this permit does not received the goods after purchasing this license. His/her funds would be refunded back maximum 72 hours after laying down a complain. International laws would be taken into consideration.

However all necessary efforts has been put in place to avoid unforeseen circumstances with the use of this procedure.

-Upon issuing of the **OBLIGATION BUYERS PERMIT REGISTRATION**, the consignment would be forward to our recognized Freight and export Agency for shipment procession to the Buyer3 designated refinery.

**Article 7:** Any Infraction of the depositions regulated by the decree at hand will be punished in accordance with the set rules and regulations governing binding this body.

**Article 8:**decree at hand becomes effective from the date of signatory by the office concerned; it ha3 been registered and published in the official Journal in French and English languages
